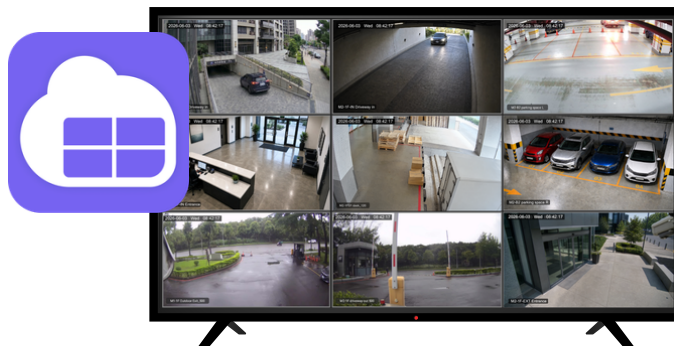

Included with EnGenius Cloud Surveillance deployments, it turns a Google TV into a mission-critical video wall without traditional NVRs or complex VMS software. With serverless deployment, cloud-managed setup, and LAN-direct streaming, EnGenius Sight enables security teams and operations staff to monitor multiple live camera feeds and respond faster using only a TV remote.

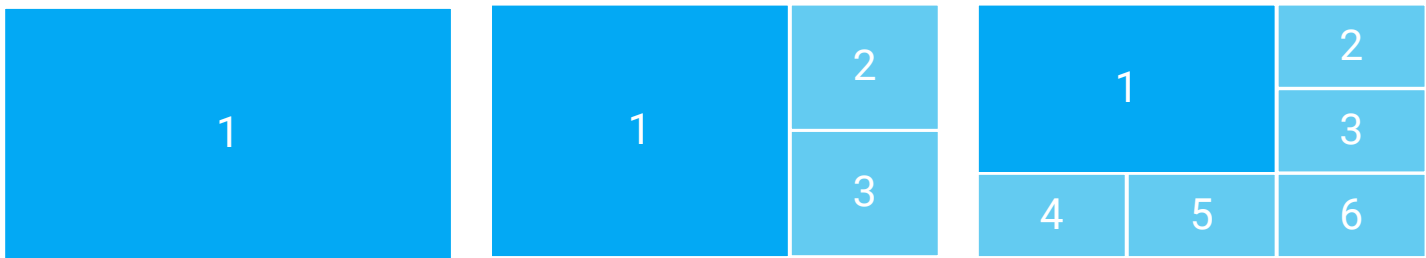
- **Smart TV Extension:** Display the camera feeds already managed in EnGenius Cloud Surveillance directly on a smart TV.

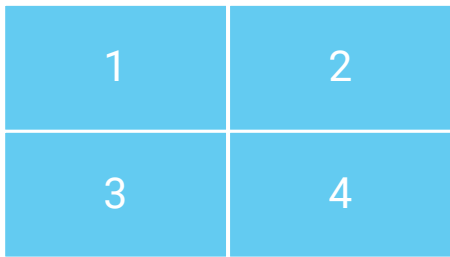
Focused Monitoring Layout Grids (1, 1+2, 1+5-Grid)

Ideal for highlighting a critical target while maintaining visibility of immediate surroundings.



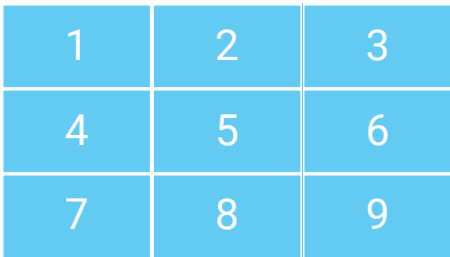
Standard Multi-Zone Layout Grid (2x2-Grid)

Comprehensive Overview Layout Grids (3x3-Grid)

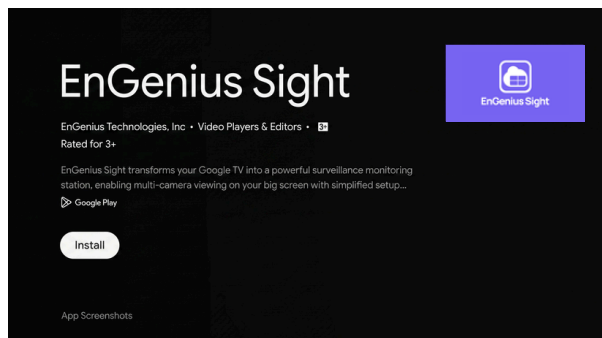
Excellent for high-density environments or headquarter control centers tracking multiple sites simultaneously.



Deployment

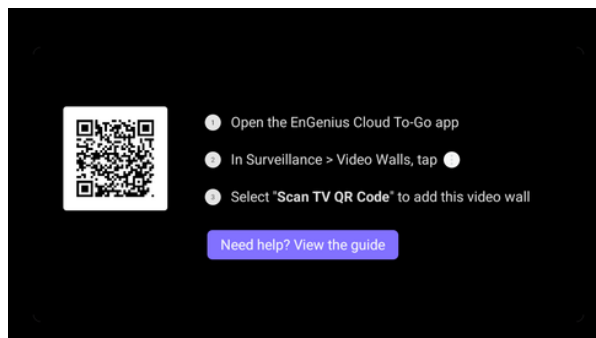
Step1: Install App

Download EnGenius Sight from the Google Play Store on Google TV.



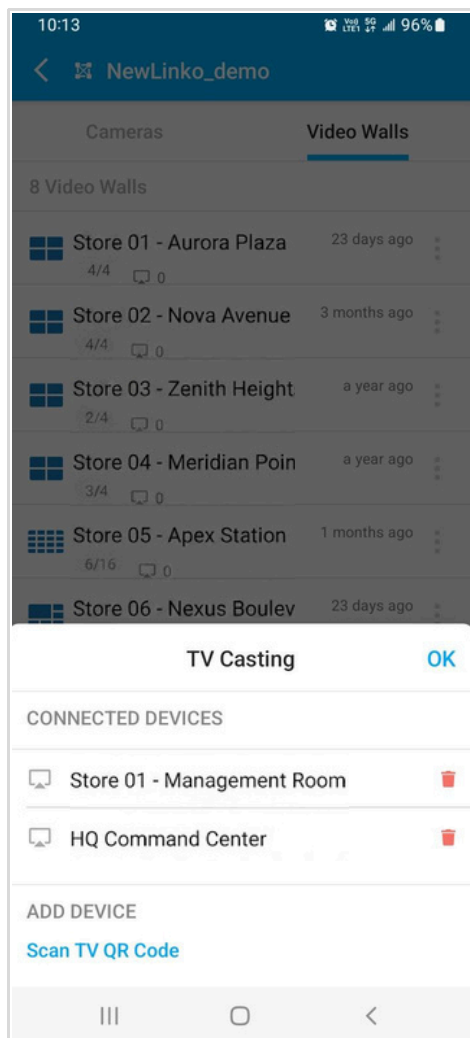
Step2: QR Code Pairing for Smart TV

Use the EnGenius Cloud-To-Go mobile app to scan the secure QR code displayed on the TV.



Step3: Assign Video Walls to Smart TV

Select camera groups in EnGenius Cloud-To-Go and assign them to the paired smart TV.
